III. Committee Reports

A. Academic Policy Committee: Deb Rotella, (Assistant Professor SSS, CU) reported that they will have several policies ready for Senate in February 2025.

B.IT Subcommittee: Matthew McKeague, (Associate Professor Media & Journalism, CU) said that they have sent out some surveys to get feedback on what technical polices may still be needed.

C.Enrollment Management Subcommittee: No report.

E. DEI Committee: Christopher Cummings, (Associate Professor, CU) stated that they are working on the Time, Place and Manner Policy.

F. Finance Committee: Dina Clark, (Associate Professor Accounting, CU) said that they are working through 3 policies.

G. Student Affairs Committee: Erin Kennedy, (Professor Psychology, CU) reported that they are working a couple policies for spring.

H. First Year Experience Subcommittee: Jennifer Demchak, (Professor Environmental Sciences, CU) said that they will be doing 8 sections of FYS for spring. Looking at what the fall will look like.

Jackie Borst raised a concern about section 6.1 not including SAT's scores as an admission requirement. Brooke Harlow made a motion to approve with amended verbiage that states that certain programs may require additional testing scores such as SAT scores. Tess Fosse, (Chief Accessibility Officer, CU) seconded. Vote for approval of policy with amendment via zoom poll. Motion carried.
- E. <u>Interim Policy on Emeritus Status Policy</u> and <u>Procedure</u>: Jessica Bently, (Associate Professor Exceptionality Programs, CU) made a motion, Atika Benaddi, (Assistant Professor Economics, CU) Seconded. Vote to approve policy as is via zoom poll. Motion carried.

It will then go to the Council of Trustees for endorsement. Working on organizing evidence inventory and preparing for the March 23rd – 26th visit from Middle states.
- VIII. Remarks for the Good of the Order: Eric Hawrelak raised concern about what happens to old PRPs (Policies) once they are withdrawn? Mark Decker explained that policies when withdrawn are being taken down from public view on the website but are still accessible if requested. Brooke Harlow expressed concern with this and does not like that they are not more easily accessible. Mark Decker said that senate leadership would re-visit and investigate it.
