HEERF III (ARP) Reporting (Initial Summary)

On March 11, 2021, the American Rescue Plan (ARP) was passed to provide additional relief to address the continued impact of COVID-19. ARP funds provided \$39.6 billion in support to higher education institutions to serve students. Under ARP section 2003 (a)(1), Lock Haven University was allocated \$9,038,552 (\$4,555,823 for the student portion). Decisions regarding the distribution of funds is ongoing and students will be notified via their LHU email when they are available.
